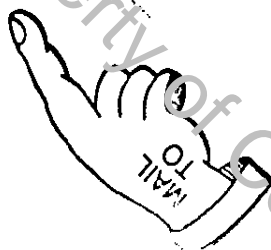

That part of Lots 2 through 7, inclusive and that part of the South 1.524 meters [5 feet] of Lot 8 in Block 19 in Dixmoor, being a subdivision of the Northeast Quarter of the Northeast Quarter of Section 36, Township 36 North, Range 13 East of the Third Principal Meridian and part of the North Half of the North Half of Section 31, Township 36 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded June 6, 1927 as document 9675674, in Cook County, Illinois, described as follows:

Beginning at the northeast corner of said Lot 7; thence southerly 42.554 meters [139.61 feet] (139.68 feet, recorded) along the easterly line of said Lots 4, 5, 6 and 7 on a curve to the right having a radius of 54.864 meters [180.00 feet], the chord of said curve bears on an assumed bearing of South 2 degrees 30 minutes 38 seconds East, 41.495 meters [136.14 feet] to the southeasterly corner of Lot 4; thence South 19 degrees 42 minutes 34 seconds West along tangent, being also the easterly line of said Lots 2 and 3 a distance of 15.241 meters [50.00 feet] to the southeasterly corner of Lot 2; thence North 70 degrees 17 minutes 26 seconds West along the southerly line of said Lot 2 a distance of 1.524 meters [5.00 feet] to a point 1.524 meters [5.00 feet] normally distant Westerly of the easterly line of Lot 2; thence North 19 degrees 42 minutes 34 seconds East along a line 1.524 meters [5.00 feet] normally distant Westerly and parallel with the easterly line of said Lots 2 and 3 a distance of 15.241 meters [50.00 feet]; thence northerly 35.284 meters [115.76 feet] along a curve to the left, being 1.524 meters [5.00 feet] radially distant Westerly and concentric with the easterly line of said Lots 4, 5, 6 and 7, having a radius of 53.340 meters [175.00 feet], the chord of said curve bears North 0 degrees 45 minutes 32 seconds East, 34.644 meters [113.66 feet]; thence South 74 degrees 32 minutes 32 seconds West 6.104 meters [20.03 feet] to a point 7.620 meters [25.00 feet] radially distant Westerly of the easterly line of said Lot 7; thence northerly 5.101 meters [16.74 feet] along a curve to the left, being 7.620 meters [25.00 feet] radially distant Westerly and concentric with the easterly line of said Lot 7, having a radius of 47.244 meters [155.00 feet], the chord of said curve bears North 21 degrees 38 minutes 15 seconds West, 5.098 meters [16.73 feet]; thence North 24 degrees 43 minutes 50 seconds West along tangent, being 7.620
