

SUBORDINATION OF MORTGAGE

SUBORDINATION OF MORTGAGE OR TRUST DEED

This Subordination Agresment (the "Agreement") is made and entered into this 22ND day of DECEMBER 1998 by and among MidAmerica Bank, fsb., (the "Lender"), MIDAMERICA BANK, FSB (the "Subordinating Party") and STEPHEN J SULLIVAN, AND BARBARA E SULLIVAN, HUSBAND AND WIFE

(hereinafter collectively referred to as the "Borrowers").

Whereas, the Borrowers are indebted to the Subordinating Party by reason of a $_{\rm NOTE}$ in the amount of \$49,000.00 with interest payable as therein provided; and, in order to secure said NOTE, the Borrowers did execute a Mortgage/Trust Deed in favor of the Subordinating Party, dated OCTOBER 16, 1992 and recorded in the office of the Recorder of Deeds of COOP. County, Illinois on OCTOBER 29, 1992 as document No. 92803911 for certain premises located in COOK County, Illinois, ("Property") described as follows:
