Partial Release Deed

KNOW ALL MEN BY THESE PRESENTS, that BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION, a National banking association, (the "Bank"), 231 S. LaSalle Street, Chicago, Illinois 60697, in consideration of ONE DOLLAR (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby RELEASE, CONVEY AND QUIT CLAIM unto JS II L.L.C., an Illinois Limited Company (THE "Borrower"), and its successor and assigns, all of the right, title, interest, claim or demand whatsoever in the real estate legally described as Condominium Unit No. H-38 on Exhibit A attached hereto and hereby made a part hereof, together with all appurtenances and privileges thereunto belonging or appertaining (collectively, the "Released Real Estate"), which the Bank may have acquired under that certain Mortgage with Assignment of Rents, Security Agreement and Fixture Filing dated February 23, 1998 and recorded as Document No. 98572006 in the Recorder's Office of Cook County, in the State of Illinois on July 2, 1998. (The Mortgage) and encumbering the Released Real Estate and other property (the "Property").

THIS IS A PARTIAL RELEASE only as to the Unit described above as the Released Real Estate.

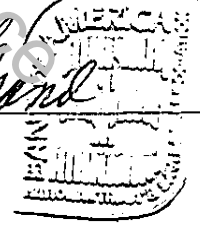
