THE COVENANTS, CONDITIONS AND PROVISIONS PREVIOUSLY REFERRED TO ARE:

- 1. Mortgagors shall (a) promptly repair, restore and rebuild any buildings or improvements now or hereafter on the premises which may become daineged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note, (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said process; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the notes duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm (and flood damage, where the lender is required by law to have its loan so insured) under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the notes, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the notes, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the notes, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management, and operation of the premises during the whole of said period. Trustee has no duty to examine the title, location, existence, or condition of the Premises, or to inquire into the validity of the signatures or the identity capacity, or authority of the signatories on the note or the trust deed, nor shall Trustee be obligated to record this trust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or or or sissions hereunder, except in case of its own gross negligence or misconduct or that of the agents or employees of Trustee, and it may require indemnities satisfactory to it before exercising any power herein given.

This Rider is attached to and made a part of that certain Trust Deed dated, November 12, 1998, made by BRUCE ADELMANN AND JOSEPH ZUGALJ, as Mortgagor, to CHICAGO TITLE AND TRUST COMPANY, as Trustees.

- R1. In the event of any conflict between the terms of this Rider and the terms of the Trust Deed to which it is attached (the "Trust Deed"), the terms of this Rider shall prevail.
- R2. In the event of any default by Mortgagor under the terms of the Trust Deed, the holder of the note referred to therein (the "Holder") may require, upon ten (10) days' notice to Mortgagor, that Mortgagor pay Holder on the day monthly payments are due under the Note until the note is paid in full, a sum ("Funds") equal to one-twelfth (1/12) of (a) yearly taxes and assessments which may attain priority over the Trust Deed and (b) yearly hazard insurance premiums. These items are called "escrow items." holder may estimate the Funds due on the basis of the current data and reasonable estimates of future escrow items. Holder shall not be required to pay Mortgagor any interest or earnings on the Funds. The Funds are pledged as additional security for the sums secured by the Trust Deed.

If the amount of the Funds held by Holder together with the future monthly payments of Funds payable prior to the due dates of the escrow items shall exceed the amount required to pay the escrow items when due, the excess shall be at Mortgagor's option, either promptly repaid to Mortgagor or credited to Mortgagor on monthly payments of Funds. If the amount of the Funds held by Holder is not sufficient to pay the escrow items when due, Mortgagor shall pay to Holder any amount necessary to make up the deficiency in one or more payments as required by Holder.

Upon payment in full of all sums secured by this Trust Deed, Holder shall promptly refund to Mortgagor any funds held by Holder. If under Paragraph 7 of the Covenants, Conditions and Provisions of the Trust Deed, the Premises is sold, Holder shall apply, no later than immediately prior to the sale of the Premises, any funds held by Holder as a credit against the sums secured by the Trust Deed.

- R3. If all or any part of the Premises or any interest in ti is sold or transferred without Holder's prior written consent, Holder may, at its option, require immediate paymera in full of all sums secured by the Trust Deed. If Holder exercises this option, Holder shall give Mortgagor notice of acceleration. The notice shall provide a period of not less than ten (10)days from the date the notice is delivered or mailed within which Mortgagor must pay all sums secured by the Trust Deed. If Mortgagor fails to pay these sums prior to eh expiration of this period, Holder may invoke any remedies permitted by the Trust Deed without further notice or demand, on Mortgagor.
- R4. Any notice to Mortgagor provided for in the Trust Deed or this Rider shall be given my mailing it by Certified Mail, return receipt requested, directed to the Premises or any other address Mortgagor designates by notice to Holder.
