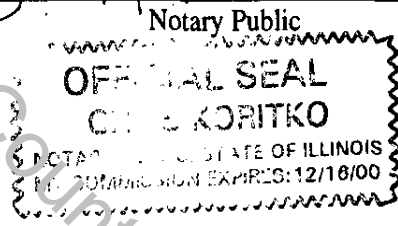

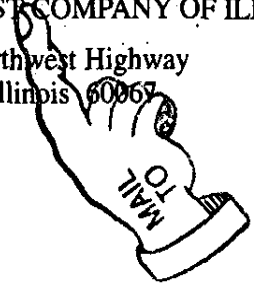

## LEGAL DESCRIPTION

Unit 954-G201 and Parking Unit 26 as delineated on the Survey of the following described parcels of Real Estate:

### PARCEL 1:

Lots 11, 12 and 13 in S.H. Kerfoot's Subdivision of the North West 1/4 of Block 7 in Laflin, Smith and Dyers Subdivision on the North East 1/4 (except 1.28 acres in the North East corner thereof) of Section 20, Township 40 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

### PARCEL 2:
