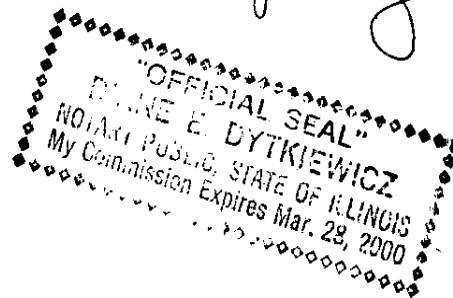

## EXHIBIT "A"

### Legal Description

RE: 97 055 031 (Cook)

Unit 108, Garage Unit 10 and Locker Unit 35, in the Grand Towers Plaza Condominium, as delineated on a survey of the following described property: Part of the East 1/2 of the Northeast 1/4 of Section 29, Township 40 North, Range 12, East of the Third Principal Meridian in Franklin Park, Cook County, Illinois, which survey is attached as Exhibit "E" to the Declaration of Condominium made by Affiliated Bank/Franklin Park, Successor by merger with First State Bank and Trust Company of Franklin Park, as Trustee under Trust Agreement dated May 19, 1987 and known as Trust Number 1217 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on December 30, 1987 as Document Number 87680416, together with their undivided percentage interest in said parcel, excepting from said parcel all property and space comprising all the units thereof defined and set forth in said Declaration and survey, as amended from time to time, in Cook County, Illinois.
