WHEREAS, the City agrees, through its Building & Zoning Officer, to allow the installation of a lawn sprinkler system in its right-of-way or easement, subject to the following conditions, until such time as their license is revoked by the City upon thirty (30) days written notice to the Title Holder(s):

- 1. The City of Rolling Meadows assumes no responsibility because of the installation and the Owner will hold the City harmless of and from any loss, cost, damage or expense, including any reasonable attorney's fees, in any action arising out of or in the course of the use, existence or maintenance of said installation.
- 2. Existence of the sprinkling system in the public right-of-way or easement shall not in any way interfere with the right of the City to excavate therein for repair, maintenance or installation of any public utilities or for any other purpose, nor vito the right of the City to otherwise maintain, clean, plow, repair, construct or reconstruct therein.
- 3. The City will not be required to maintain or replace any of such system as may be damaged by any such work, or by any street or other public utility maintenance, cleaning, plowing, repair, construction or reconstruction operation.
- 4. All sprinkling heads will be so located, shielded, adjusted or directed that they will not sprinkler the public pavement or public sidewalk when in operation.
- 5. All sprinkling heads will be so constructed that they will not project above ground level when not in operation.
- 6. This agreement shall be binding upon and inure to the benefit of the heirs, grantees, successors and assigns of the partie: heleto and shall constitute a covenant running with the land with respect to the private premises served by the sprinkler system permitted hereunder.
