THE UNDERSIGNED LIEN CLAIMANT, Roughneck Concrete Drilling & Sawing Co., Inc., of 8400 Lehigh Ave, Morton Grove, IL hereby files a claim for Mechanics Lien against Hot Tuna, Inc., 1177 North Elston Avenue, Chicago, IL (hereinafter referred to as "Tenant") Ameri-Jam (hereinafter referred to as "Contractor") and Aema Bank #10-4028 Corus Bank #10-4028 (hereinafter referred to as "Owner"), and all other persons having or claiming an interest in the below described real estate, and states as follows:

1. On August 10, 1998, Owner owned the following described land in the County of Cook, State of Illinois, to wit:

Commonly known as Hot Tuna, Inc., 1177 North Elston Ave, Chicago, IL and having the following permanent index number 17-05-307-003 / 17-05-307-006 and hereinafter together with all improvements referred to as the "premises";

2. On information and belief, on or about August 10, 1998, Owner, Owner's Tenant or one knowingly permitted by the Owner to do so entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction of repairs, alterations;

3. On August 10, 1998, Contractor made a subcontract with lien claimant to furnish and supply labor, materials and equipment to Hot Tuna, Inc. in the amount of \$595.00 for said improvement;

4. At the special instance and request of Contractor, lien claimant furnished extra and additional materials to and extra and additional labor for said premises in the amount of \$595.00;

5. On August 10, 1998, lien claimant substantially completed (all required by said contract and extras to be done)(labor, materials and work to the value of \$595.00) [except that from time to time thereafter lien claimant has, at the request of [Owner] [and] [Contractor], returned to the premises to perform certain completion work, the last occasion being on or about August, 10, 1998];

6. Owner, or the agent, architect or superintendent of Owner (cannot, upon reasonable diligence, be found in said County)(do not reside in said County);

7. On information and belief, the labor, materials supplies, equipment and services for said work and in the improvement of the aforementioned premises performed and supplied by lien claimant was done with the knowledge and consent of the Owner of the beneficial interest in the above named Trust holding record title to the premises;
