#### (C) Borrower's Promises. You promise to:

- (1) Pay all amounts when due unde your Agreement, including interest, and to perform all duties of the Agreement and/or this Mortgage. ('Mortgagor who has not signed the Agreement has no duty to pay amounts owed under the Agreement.)
