This Schedule A-1 is attached to and made part of a

### REAL ESTATE LEGAL DESCRIPTION East Dundee, Cook County, IL

That part of the Southwest Quarter of Section 30 lying northerly of the north right-of-way line of Illinois State Route 72 and commonly known as New Higgins Road, and westerly of the easterly right-of-way of Healy Road, (except the west 190.00 feet thereof and except that part conveyed to the Department of Public Works and Buildings of the State of Illinois by Document No. 12378247 recorded October 5, 1939 for highway purposes described as follows: That part of the Southwest Quarter of said Section described as being a strip of land 66 feet in width running from the northerly right-of-way line of the proposed dual highway of State Bond Issue Route 63 to the centerline of Higgins Road as now traveled, centerline of said 66 foot strip being described as follows: Commencing at the southwest corner of Section 30; thence North along the west line of said Section; a distance of 1,412.73 feet to a point; thence southeasterly along a line which makes an angle of 59 degrees 01 minutes from the South to the southeast with said west line a distance of 109.59 feet to a point, said line being said northerly right-of-way line of the proposed dual highway; thence southeasterly along a curve convex to the southwest having a radius of 10,017.06 feet and tangent to the last described course, said curve being said northerly right-of-way of proposed dual highway, a distance of 762.20 feet to the point of beginning; thence northeasterly along a line, a distance of 245.11 feet to a point in the aforesaid centerline of Higgins Road as now traveled, said point being 894.51 feet from aforesaid west line of said Section 30 as measured along said centerline of Higgins Road, in Township 42 North, Range 9 East of the Third Principal Meridian.

The South Half of Lot 1 and South 5 acres of the North Half of said Lot 1 (except that part of said Lot 1 and of said South 5 acres lying southeasterly of the northwesterly right-of-way line of Healy Road) in the Northwest Quarter of Section 30, Township 42 North, Range 9 East of the Third Principal Meridian, in Cook County, Illinois. Also the South Half of Lot 2 and the South 5 acres of the North Half of said Lot 2 (except that part of said Lot 2 and of said South 5 acres lying southeasterly of the northwesterly right-of-way line of Healy Road) in the Northwest Quarter of Section 30, Township 42 north, Range 9 East of the Third Principal Meridian, in Cook County Illinois, (excepting the west 190.00 feet of the South Half of said Lot 2 and also excepting the west 190.00 feet of the South 5 acres of the North Half of said Lot 2 conveyed to the Commonwealth Edison Company by Document No. 1845231, recorded April 10, 1962.)
