

MODIFICATION AGREEMENT

WHEREAS, the maturity date for the above referenced mortgage will remain as originally stated, 6th DAY OF JANUARY 2004.

AND KNOW THEREFORE, it is hereby agreed that said mortgage and supplement thereto, and any obligation or obligations secured thereby, be and the same are hereby modified, altered and amended in a manner so that JOSEPH M. SCHUCH AND GAYLE T. SCHUCH, hereby agrees to pay LIBERTY FEDERAL BANK, formerly known as SOUTHWEST FEDERAL SAVINGS AND LOAN ASSOCIATION its successors and assigns, the amount remaining unpaid on said mortgage indebtedness in the sum of ONE HUNDRED THOUSAND AND NO/100 (\$100,000.00), with interest calculated on the outstanding balance at the rate of Prime for the remaining term of the loan as was stated in the original note dated JANUARY 6, 1997. Payments are due on the 15th of every month until the whole of said independences, including interest, shall have been paid except that if not sooner paid, the final payment of principal and interest shall be due and payable on the 6th DAY OF JANUARY 2004.
