SUBCONTRACTOR'S NOTICE AND CLAIM FOR LIEN

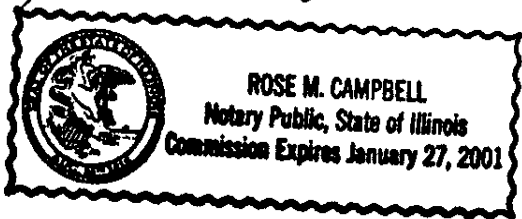
