SECOND AMENDMENT TO MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF RENTS AND FIXTURE FILING

This Second Amendment to Mortgage, Security Agreement, Assignment of Rents and Fixture Filing (this "Amendment") made this 29th day of January, 1999, by and between American National Bank and Trust Company of Chicago, a national banking association ("Mortgagee") and Holy Family Medical Center, an Illinois not-for-profit corporation ("Mortgagor").

WITNESSETH

WHERE S Mortgagor is indebted to Mortgagee in the original principal amount of up to \$10,310,000, which indebtedness is evidenced by that certain Construction Loan Note, dated as of December 23, 1997, executed by Mortgagor (as amended, extended, modified or supplemented from time to time, herein the "Note"), which Note provides for the payment of the indebtedness described therein;

WHEREAS the Note was issued under and in connection with a Construction Loan Agreement between Mortgago and Mortgagee dated July 30, 1997 (as amended, extended, modified or supplemented from time to time, herein called the "Loan Agreement");

WHEREAS the obligations of Mortgager to Mortgagee evidenced by the Note, and certain other obligations of Mortgager to Mortgagee, are secured by a Mortgage, Security Agreement, Assignment of Rents and Fixture Filing, dated July 30, 1997, and recorded against the premises legally described in Exhibit A hereto in the office of the Recorder of Deeds of Cook County, Illinois on August 1, 1997 as Document No. 97561374 as amended by that certain First Amendment to Mortgage, Security Agreement, Assignment of Rents and Fixture Filing, dated as of December 23, 1997 by and between Mortgager and Mortgage and also recorded against the premises legally described in Exhibit A hereto in the office of the Recorder of Deeds of Cook County, Illinois on December 24, 1997 as Document No. 97968741 (as amended, extended, modified or supplemented from time to time, the "Mortgage"),

WHEREAS Mortgagor has executed and delivered to Mortgagee a Second Amendment to Construction Loan Agreement of even date herewith, which amends the Loan Agreement to, among other things, extend the "Maturity Date" (as that term is defined in the Loan Agreement) to July 30, 1999;

WHEREAS the Mortgagor and Mortgagee desire to amend the Mortgage to give effect to the extension of said Maturity Date;

Now, therefore, in consideration of the premises, and the mutual covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. The recitals contained in this Amendment are hereby incorporated into the terms of this Amendment and form an integral part thereof.
- 2. In order to give effect to the foregoing, clause (a) of the first paragraph of the Mortgage following the heading "WITNESSETH" on page 1 is amended by deleting it in its entirety and substituting the following therefor:
- "(a) all indebtedness of the Mortgagor to the Mortgagee now or hereafter existing, including without limitation the principal sum of Ten Million Three Hundred Ten Thousand Dollars (\$10,310,000.00), payable in accordance with the terms of a Construction Loan Note dated December 23, 1997, payable by the Mortgagor to the order of Mortgagee, the final payment of which is due not later than July 30, 1999 together with interest thereon at the rates stated therein and in the Loan Agreement (as hereafter defined) (such cromissory note, and all extensions, renewals and modifications thereof, and all notes issued in substitution or exchange therefor, being herein called the "Note"),"
- 3. Section 27 of the Mortgage is amended to delete the Mortgagor's address of "33 North LaSalle, Chicago, Illinois 60690" and to replace said address with "120 South LaSalle Street, Chicago, Illinois 60603".
- 4. In all other respects, the Mortgage shall remain unmodified and in full force and effect, shall secure in all respects the Note and all other terms, provisions and conditions of the Mortgage are hereby confirmed and ratified by the Mortgagor. Nothing contained herein or by the discharge of the obligations evidenced by the Note shall be construed to discharge, release or otherwise modify the obligations or liens created by the Mortgage.
- 5. The provisions hereof shall be binding upon and inure to the benefit of the parties hereto and their respective legal representatives, successors and assigns. This instrument has been made and executed and delivered in the State of Illinois and shall be governed by and construed in accordance with the internal law of the State of Illinois. This Amendment may be executed and delivered in one or more counterparts, with the intention that all such counterparts, when taken together, shall constitute one and the same instrument.
