As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by New Aspen, the balance of Four Thousand, On Hundred and Thirty-Four Dollars & 72/100, (\$4,134.72), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due or to become due from Owner to New Aspen Electric, Inc.
