Said owner is entitled to credits on account thereof for payments previously made and for approved back charges in the aggregate amount of \$-0- leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of FOUR THOUSAND NINE HUNDRED AND NO/100THS (\$4,900.00) DOLLARS, for which, with interest, the claimant claims a lien on said premises, land and improvements.
