**SUBORDINATION AGREEMENT**

*THIS SUBORDINATION AGREEMENT*, made in the City of Chicago, State of Illinois this 17th day of February, 1999 by The First National Bank of Chicago, a national banking organized and existing under and by virtue of the laws of the United States of America, and doing business and having its principal office in the City of Chicago, County of Cook, and State of Illinois ("Bank).

**WITNESSETH**

*WHEREAS*, the Bank is the owner of a mortgage dated May 30, 1997 and recorded July 17, 1997 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 97514097 made by J. Kevin O'Hagan & Eileen M. O'Hagan, Husband and Wife and Loretta C. Meindl As Trustee Of The Loretta C. Meindl Trust Dated January 15, 1991 ("Borrowers"), to secure an indebtedness of \$ 47,300.00 ("Mortgage"); and

*WHEREAS*, Borrowers are the owners of that certain parcel of real estate commonly known as 3618 N. Greenview Avenue, #1, Chicago, IL 60613 and more specifically described as follows:

*WHEREAS*, First Chicago/NBD Mortgage Company, its successors &/or assigns ("Mortgagee") has refused to make a loan to the Borrowers of \$371,200.00, except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

*NOW, THEREFORE*, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee to make the loan to Borrowers, it is hereby mutually agreed, as follows:

- I. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated 2-18-99 reflecting and securing the loan made by Mortgagee to Borrowers, in the amount of Three Hundred Seventy One Thousand, Two Hundred and No/100 Dollars, and to all renewals, extensions or replacements of said mortgage; and rec'd 99184900
- II. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.

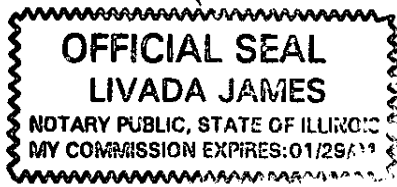
