SUBORDINATION OF REAL ESTATE MORTGAGE

NOW THEREFORE, in consideration of the premises and of the sum of one collar in hand paid, American National Bank & Trust Company of Chicago does hereby covenant and agree which the said First Chicago NBD Mortgage Company Inc., its successors and/or assigns, that the lien of the mortgage now held by American National Bank and Trust Co. of Chicago upon said premises and described above as Document No. 97837430, shall be and remain at all times a second lien subordinate to the lien thereon of the mortgage to be executed in favor of First Chicago NBD Mortgage Company Inc., its successors and/or assign, 10 secure a note in the principal amount not to exceed \$275,000.00, with interest thereon as may be provided.
