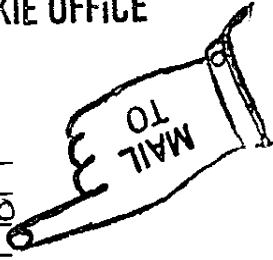

ADDENDUM


