THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois this 12TH day of FEBRUARY, 1999 by LaSalle Bank FSB, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and State of Illinois ("Bank").

Witnesseth

WHEREAS, the Bank is the owner of a mortgage dated AUGUST 26, 1998 and recorded SEPTEMBER 2, 1998 among the land records in the Office of the Recorder of Deeds of COOK County, Illinois as document number 98783696 made by MICHAEL A. PORTERA AND JESSICA M. PORTERA, HIS WIFE ("Borrowers"), to secure and indebtedness of \$30,000.00 ("Mortgage"); and

WHEREAS, Borrowers are the owners of that certain parcel of real estate commonly known as 7133 N OTTAWA AVE CHICAGO, IL 60631 and more specifically described as follows:

LEGAL DESCRIPTION: LOT 2 (EXCEPT THE NORTH 315 FEET AND EXCEPT THE EAST 30 FEET THEREOF) AND LOT 3 (EXCEPT THE NORTH 315 FEET THEREOF AND EXCEPT THE WEST 68.5 FEET IN WALPER'S SUBDIVISION OF LOT 1 IN BLOCK 5 IN CANFIELD IN THE NORTHWEST 1/4 OF SECTION 36, TOWNSHIP 41 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

WHEREAS, 6N mortgage Corp. ("Mortgagee") has refused to make a loan to the Borrowers of \$202,500.00 except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee make the loan to Borrowers, it is hereby mutually agreed, as follows:

1. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated 2-19-99 reflecting and securing the loan made by Mortgagee to Borrower, in the amount of TWO HUNDRED TWO THOUSAND FIVE HUNDRED DOLLARS AND NO/100, and to all renewals, extensions or replacements of said Mortgagee's mortgage; and
2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its successors and assigns.
