# FIAST AMENDMENT TO ACCESS EASEMENT AGREEMENT

THIS FIRST AMENDMENT TO ACCESS EASEMENT AGREEMENT ("Agreement") is made as of this 23rd day of February, 1999, by and between Altgeld Club Homeowners Association, an Illinois not-for-profit corporation ("Association"), Dan Melk Development/MCL Fullerton Altgeld, L.P., an Illinois limited partnership ("Grantor") and Cityscape Development L.L.C, an Illinois limited liability company ("Grantee"). Association, Grantor and Grantee are sometimes hereinafter referred to individually as a "Party" and collectively as the "Parties".

## RECITALS:

- A. Grantor and Grantee entered into an Access Easement Agreement dated July 10, 1997, and recorded as Document No. 97536387 (the "Agreement") by which Grantor granted to Grantee an easement for ingress and egress over, upon and across a certain parcel legally described on Exhibit C to the Agreement (the "Original Easement Parcel"). The Agreement anticipated the formation of Association and assigned certain responsibilities to it.
- B. The parties hereto now wish to increase the size of the Original Easement Parcel and modify certain other aspects of the Agreement.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Incorporation of Recitals</u>. The foregoing recitals are a material part of this Agreement are incorporated herein as if fully set forth in this Paragraph 1.
- 2. <u>Cost-Sharing</u>. Section 5 of the Agreement is hereby modified by inserting the following after the first sentence thereof:

"The maintenance and repair costs for the Easement Parcel shall be deemed to include, without limitation, the cost of (a) repairing and replacing the driveways and sidewalks on the Easement Parcel and driveways on the parcel connecting the

Easement Parcel to Fullerton Parkway, (b) clearing snow therefrom, (c) procuring insurance coverage in connection therewith, (d) real estate taxes in connection therewith, and (e) accumulating reasonable reserves for major repairs to or replacement thereof."

- 3. <u>Insurance</u>. Section 8 of the Agreement is hereby deleted and the following is hereby inserted in its place:
  - "8. <u>Insurance</u>. Grantor shall carry at all times commercial general public liability insurance, in amounts appropriate for a homeowners' association, naming as additional insureds the owners from time to time of the homes within the Single Family Parcel."
- 4. <u>Amended Grant of Easements</u>. Exhibit C to the Agreement is hereby deleted and Exhibit C hereto is hereby substituted in its place.
