

MODIFICATION AGREEMENT

This agreement, made this the 24TH day of DECEMBER 1998, by and between the Mortgagee, LIBERTY FEDERAL BANK, party of the first part, owner of the mortgage hereinafter described, and the Mortgagor(s) JILL M. LEVY, SINGLE AN UNMARRIED PERSON, representing herself to be the owner(s) of the real estate hereinafter and in said mortgage described.

UNIT 203 TOGETHER WITH ITS UNDIVIDED PERCENTAGE INTEREST IN THE COMMON ELEMENTS IN 2001 WEST WABANSIA LOFTS CONDOMINIUM AS DELINEATED AND DEFINED IN THE DECLARATION RECORDED AS DOC. NUMBER 86478671, AS AMENDED FROM TIME TO TIME, IN THE SW 1/4 OF SECTION 31, TOWNSHIP 40 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILL INOIS.

WITNESSETH:

WHEREAS, the Mortgage(s) heretofore executed a certain mortgage dated OCTOBER 20, 1998 and recorded NOVEMBER 9, 1998 in the recorder's office of COOK County, Illinois as Document Number 08006452, conveying to LIBERTY FEDERAL BANK, as mortgagee certain premises in said mortgage particularly described and which said mortgage was given to secure the payment of one certain promissory note dated OCTOBER 20, 1998, in the amount of FIFTEEN THOUSAND TWO HUNDRED FIFTY DOLLARS AND NO/100 (\$15,250.00).

WHEREAS, the maturity date for the above referenced mortgage will remain as originally stated, 15th DAY OF NOVEMBER 2005.

AND KNOW THEREFORE, it is hereby agreed that said mortgage and supplement thereto, and any obligation or obligations secured thereby, be and the same are hereby modified, altered and amended in a manner so that JILL M. LEVY, SINGLE AN UNMARRUD PERSON, hereby agrees to pay LIBERTY FEDERAL BANK, its successors and assigns, the amount remaining unpaid on said mortgage indebtedness in the sum of TWENTY-NINE THOUSAND AND NO/100 (\$29,000.00), with interest calculated on the obtaining balance-at the rate of-Prime Minus: 50% for the remaining term of the loan as was stated in the original note dated OCTOBER 20, 1998. Payments are due on the 15th of every month until the whole of said indebtedness, including interest, shall have been paid except that if not sooner paid, the final payment of principal and interest shall be due and payable on the 15th DAY OF NOVEMBER 2005.
