1. The judgment(s) hereby entered on the date(s) of 8/7/98 in the total amount(s) of \$ 2,000.00 plus \$60.00 in court costs against defendant(s) RANDI McINTOSH shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instanter.

2. A mandatory permanent injunction against defendant(s) RANDI McINTOSH his/her/their agents, heirs, successors or assigns, to fully comply with all open violations listed in the City's complaint by 11/19/98.

3. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

IT IS FURTHER ORDERED that this cause is hereby dismissed subject to the above mandatory permanent injunction, and, the above lien and personal judgment(s) against the named defendant(s) in the aforesaid amount(s).
