

## MODIFICATION OF DISCLOSURE STATEMENT AND AGREEMENT AND MORTGAGE

The grant set forth in the Mortgage is made for the purpose of securing, and shall secure payment of the Disclosure Statement with interest thereon, according to its terms, per a credit limit of \$60,000.00, as well as payment by Borrower of all sums due and owing under and performance of all obligations set forth in the Disclosure Statement and this Modification, and satisfaction and performance by Borrower of each and every obligation and agreement of Borrower set forth in the Disclosure Statement, Mortgage or this Modification.
  - 2. The credit limit as set forth in the Disclosure Statement is increased to \$60,000.00.
  - 3. All other terms, except as modified and amended by this Modification, are confirmed and ratified and all provisions thereof in the Disclosure Statement and Mortgage shall remain in full force and effect.
