1. The judgment(s) heraby entered on the date(s) of 3/19/99 in the total amount(s) of \$ 24,000.00 plus \$60.00 in court costs against defendant(s) Maritese Lister shall stand as final judgment and that leave for enforcement on said judgment(s) is hereby granted plaintiff, City of Chicago, instanter.

The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
