This assignment und power of attorney shall be binding upon and inure to the benefit of the heirs, executors, administrators, successors and assigns of the parties hereto and shall be construed as a covenant running with the land, and shall continue in full force and effect antil all of the indebtedness or liability of the undersigned to the Association shall have been fully paid, at which time this assignment and power of attorney shall terminate.

Association shall not be obligated to pe form or discharge any obligation, duty or liability under the said leases, nor shall this Assignment operate to place upon Association responsibility, for the control, operation, management or repair of the premises or the carrying out of any of the terms and conditions of said leases; nor shall this Assignment operate to make Association liable for any waste committed on the premises by the lessee under any lease or any other party, or for any negligence in the management, upkeep, repair or control of the premises, resulting in loss, injury or death to any tenant, licensee, employee, invitee or stranger.

The undersigned shall, and does hereby agree to, indemnify are hold Association harmless of and from any and all liability, loss or damage which it may or might incur under said leases or under or by reason of this Assignment and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alleged obligations or undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in said leases. Checks for all or any part of the rental collected under this Assignment of Rents shall be made to the exclusive order of the Association.

It is further understood and agreed that the Association may, at its discretion, retain, appoint or employ attorneys, agents or servants or may make application for the appointment of a receiver, whether such receivership be incident to foreclosure or otherwise, for the purpose of exercising any of the powers and authority herein granted and pay the reasonable fees thereof.

Any such party shall be liable to account only for the rents actually received.

It is understood and agreed that the Association will not exercise any of its rights under this Assignment until after default in the payment of any indebtedness or liability of the undersigned to the Association. Notwithstanding the foregoing, this Assignment of Rents shall be deemed a present assignment.
