rents, and any other charges whatsoever now existing or hereafter levied or assessed upon the Property, or upon the interest therein created by this Mortgage and, upon Lender's request, shall deliver to Lender satisfactory evidence of payment thereof. Borrower shall preserve and maintain the liens created hereby on the Property, including any improvements hereafter made a part of the realty. Borrower will not let any mechanic's or other workmen's judgment lien attach to the Property.

3. Application of Payments. Unless applicable law provides otherwise, all payments received by Lender shall be applied by

Lender according to the terms of the Note.

a. Prior Mortgages and Deeds of Trust; Charges; Lieus. Borrower shall perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lieu which has priority over this Mortgage, including Borrower's coverants to make payments when due. Borrower shall pay or cause to be paid all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority hereover, and leasehold payments or ground rents, if any.

12. Notice. Except for any notice required under applicable law to be given in another manner. (a) any notice to Bortower provided for in this Mortgage shall be given by delivering it or by mailing such notice by certified mail addressed to Bortower at the Property Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given in the manner designated herein.

U.S. Governing Law; Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. The foregoing sentence shall not limit the applicability of federal law to this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used herein, "costs", "expenses" and "attorneys' fees" include all sums to the extent not positive by applicable law or limited herein.

14. Borrower's Copy. Derrower shall be furnished a copy of the Note and Mortgage at the time of execution hereof.

15. Rehabilitation Local Experiment. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair or other ten agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Borrower may have against partice of supply labor, materials or services in connection with improvements made to the Property.

17. Accelerations Remedies. Except as provided in paragraph 1/ her of, upon Borrower's breach of any covenant or agreement of Borrower in this Mortgage, including the covenants to pay when the are sums secured by this Mortgage, Lender prior to acceleration shall give notice to Borrower as provided in paragraph 12 hereof specifying; (1) the breach; (2) the action required to cure such breach not less than 10 days from the date the notice is mailed of Parrower, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice was result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding, and sale of the Property.
