ORDER APPROVING SHERIFF'S REPORT OF SALE AND DISTRIBUTION

Lot Fourteen (14) in the subdivision of Lot Twenty Four (24) (except the south four (4) acres thereof) in School Trustees' Subdivision of Section Sixteen (16), Township Thirty Seven (37) North, Range Fourteen (14) East of the Third Principal Meridian in Cook County, Illinois.

The Court finds that the said Sheriff has in all things proceeded in accordance with all the terms of the Judgment heretofore entered in making the sale of the premises involved herein and in distributing the proceeds derived from said sale; and

The Court further finds that the proceeds of sale of said premises were in the sum of \$167,000.00 and that said Sheriff has retained therefrom for his fees and commissions in accordance with the terms of said judgment, the sum of \$669.00; that he has paid to SHAPIRO & STARR, P.C., attorneys for Plaintiff, to apply on account of the amount due said Plaintiff under the Judgment herein, the balance of said proceeds of sale totaling \$166,331.00; and

The Court further finds that under said Judgment there remains due and unpaid to the said Plaintiff the sum of \$1.00 together with interest thereon at the rate of nine percent per annum from the date of sale.

Judgment is hereby entered in favor of the Plaintiff, if any, and the mortgage lien of the Plaintiff shall be subject free from during the period of redemption subject to further order of court.

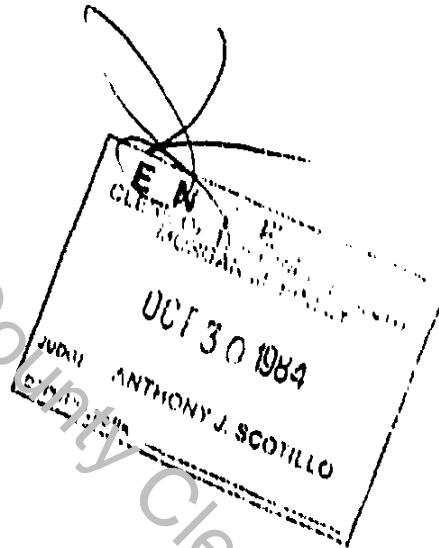
