UNIT NO. 1 in the 5419 South Massasoit Avenue Condominium, as delineated on a survey of the following described real estate: Lots 4, 5, 6, and the North One (1) foot of Lot 7 in Brun's Sub-division of Lots Thirty Four (34) and Thirty Five (35) in the Subdivision of that part of the Southeast Quarter (1/4) of Section 8, Township 38 North, Range 15, East of the Third Principal Meridian lying South of the Center Line of Archer Avenue, all in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration of Condominium Ownership made by American National Bank and Trust Company of Chicago, a national banking association, as Trustee under Trust No. 46278, registered in the Office of the Registrar of Titles, Cook County, Illinois, as Document No. LR 3421406; together with its undivided interest in the Common Elements.

Party of the first part also hereby grants to parties of the second part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of remaining property described therein.

This Condominium Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

Subject to Declaration of Easement by Finitzo Brothers, Inc. dated the 11th day of February, A.D., 1965, and registered in the Office of the Registrar of Titles, Cook County, Illinois, as Document No. IN 2215756, which is incorporated herein by reference thereto. Party of the first part grants to the parties of the second part, their successors and assigns, as an easement appurtenant to the premises hereby conveyed the easement created by said Declaration of Easement for the benefit of the owners of the parcel of realty herein described. Party of the first part reserves to itself, its successors and assigns, as an easement appurtenant to the remaining parcels described in said Declaration of Easement, the easement thereby created for the benefit of said remaining parcels described in said Declaration of Easement and this conveyance is subject to the said easement and the right of the party of the first part to grant said easement in the conveyances and mortgages of said remaining parcels or any of them, and the parties hereto, for themselves, their heirs, successors and assigns, covenant to be bound by the covenants and agreements in said document set forth as covenants running with the land.
