

The consequences of the foregoing fluctuations in investment, and especially those resulting from changes in the price level, are now well known. The effect of such changes on investment is, however, not fully understood. It is generally agreed that investment is positively related to the rate of interest, but the exact nature of this relationship is not clear.
