Number 538439;



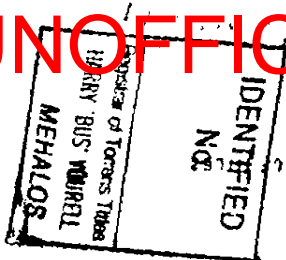
