

I further certify that the capital stock of the said bank is divided into 212,017 shares of \$1.00 each. The 134,000 shares were represented at the said meeting and that 134,000 shares, or four tenth's part of the whole represented by the whole stock of such institution, voted in favor of the above resolution.


