

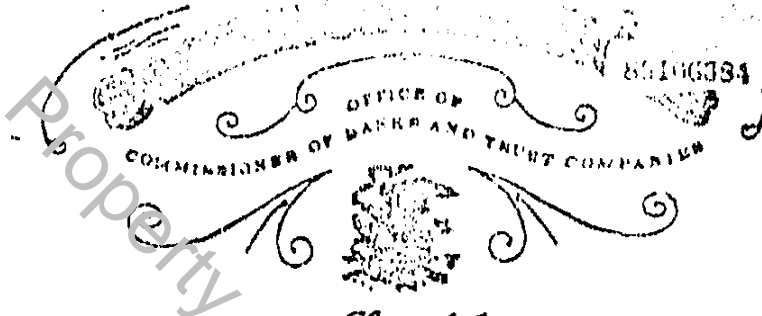

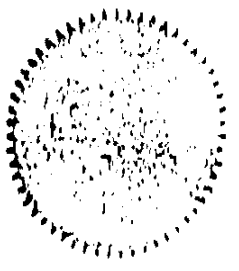

I hereby certify that at a regular meeting of the stockholders of First Bank and Trust Company, Peatline, Illinois, located at Peatline, Illinois, held on the 12th day of March, A.D. 1909, a report of said stockholders was presented and that the following resolution regarding the charter of this bank was adopted:

RESOLVED, that the Charter of First Bank and Trust Company, Peatline, Illinois, be amended to change the name to First Bank and Trust Company of Illinois, subject, however, to the approval by the Commissioner of Banks and Trust Companies of the State of Illinois of any amendment to the Charter.

And I further certify that this action was taken in accordance with the provisions of an act of the General Assembly of the State of Illinois known as the "Illinois Banking Act" approved May 11, 1905 and amended January 1, 1907, as amended.

I further certify that the capital stock of the said bank is divided into 222,000 shares of Five dollars each, of which 204,450 shares were represented at the said meeting and that 204,450 shares, at least two-thirds of all the votes represented by the whole stock of such institution, voted in favor of the above resolution.

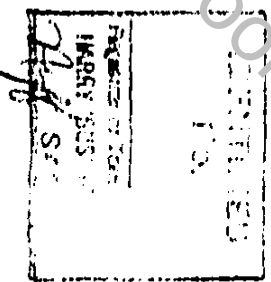
