THAT on 20 November, 1985, the claimant made a contract with Chicago Freight Station, Inc., authorized or knowingly permitted by said owner to make said contract to furnish material and labor to repair a damaged overhead door and operator for the building existing on said land for the sum of \$559.95, and on 22 November 1985, completed thereunder all required by said contract to be done.

THAT at the special instance and request of Chicago Freight Station, Inc., as hereinabove authorized, the claimant furnished extra and additional materials at and additional labor on said premises for the further improvement thereof for the value of \$891.04 and completed same on 23 January 1986.

THAT said owner is entitled to credits thereof as follows, to-wit:
