This Indenture, Made March 17, 1986, between Western National Bank of Cicero, a National Banking Association, not personally but as Trustee under the provisions of a Deed or Deeds in trust duly recorded and delivered to said Bank in pursuance of a Trust Agreement dated March 17, 1986 and known as Trust No. 9774 herein referred to as "First Party," and CHARLES MALLEN herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS First Party has concurrently herewith executed One note bearing even date herewith in the PRINCIPAL SUM OF

TWENTY FIVE THOUSAND THREE HUNDRED SIX and 80/100---DOLLARS, made payable to ~~JOSEPH E.~~ Western National Bank of Cicero and delivered, in and by which said Note, the First Party promises to pay out of that portion of the trust estate subject to said Trust Agreement and hereinafter specifically described, the said principal sum as follows:

In full accordance with Note dated March 17, 1986 to Western National Bank of Cicero in the amount of \$25,306.80 executed by JOSEPH E. LANG and HELEN E. LANG, and all extensions, renewals or refinancings thereof;

and all of said principal and interest being made payable at such banking house or trust company in Cicero Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of

In case more than one note is above referred to and described, any reference hereinafter to "note" shall be understood to mean "notes" and any of the rights, powers, privileges and authorities herein granted shall be exercisable by the holder or holders of any one or more of the notes secured hereby.

NOW, THEREFORE, First Party to assure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents grant, release, alien and convey unto the Trustee, its successors and assigns, the following described Real Estate situated, lying and being in the COUNTY OF Cook AND STATE OF ILLINOIS, to wit:

The North half of Lot 3 In Block 11 in New Provision, being a Subdivision of the South 26.42 chain of the West half of the South East quarter of Section 21, Town 39 North, Range 12, East of the Third Principal Meridian, in Cook County, Ill.
