A Tract of Land comprising part of LOT EIGHT (8) in BLOCK EIGHT (8) in South Washington Heights, a Subdivision of the Northwest Quarter (NW 1/4) of Section Thirty (30), Township Thirty-Seven (37) North, Range Fourteen (14), East of the Third Principal Meridian, Cook County, Illinois, said Tract of Land being described as follows: -Beginning at the intersection of the Westerly line of said Lot Eight (8) with a line drawn parallel with and 54.82 feet South of (measured at right angles thereto) the North line of said Lot Eight (8), and running thence East along said parallel line, a distance of 136.48 feet to an intersection with a straight line drawn from a point on the South line of Lot Nine (9) in said Block Eight (8), said point being 103.57 feet East of the Southwesterly corner of said Lot, to a point on the North Line of Lot Seven (7) in said Block Eight (8), said point being 107.41 feet East of the Northwesterly corner of said Lot Seven (7); thence Northeasterly along said straight line, a distance of 50.31 feet to an intersection with a line drawn parallel with and 5.15 feet South of (measured at right angles thereto) said North line of Lot Eight (8); thence West along last described parallel line, a distance of 127.12 feet to said Westerly line of Lot Eight (8); thence Southwesterly along said Westerly line, a distance of 52.62 feet to the point of beginning.
