ORDER OF DISMISSAL

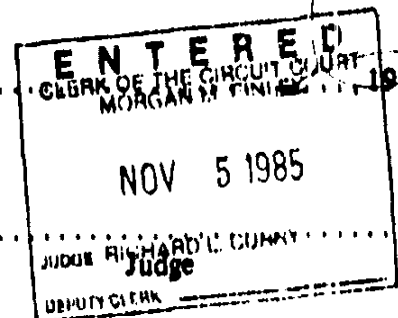
This matter coming on to be heard upon the Motion of
