If the loan secured by the Mortgage is subject to a law vinich sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed permitted limits, then: (1) any such loan charge shall be reduced by the amount necessary (c reduce the charge to the permitted limit; and (2) any sums already collected from Borrower which exceeded permitted limits will by refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower, if a refund reduces principal, the reduction will be treated as a partial prepayment under the Note.

#### LEGISLATION

If, after the date hereof, enactment of expiration of applicable laws here the effect of rendering the provisions of the Note, the Mortgage or this Adjustable Rate Rider (other than this paragraph H) unenforceable according to their terms, or all or any part of the sums secured hereby uncollectable, as otherwise provided in the Mortgage and this Adjustable Rate Rider, or of diminishing this value of Lender's security, then Lender, at Lender's option, may declare all sums accured by the Mortgage to be immediately due and payable.
