WHEREAS, a certified copy of a March 8, 1982 resolution of the Board of Directors of Guardian Savings and Loan Association, located in Chicago, illinois, and a certified copy of a March 9, 1982 resonution of the Board of Firectors of Grunwald Savings and Loan Association, located in Chicago, Illinois, and a certified copy of a March 11, 1982 resolution of the Board of Directors of United Savings and Loan Association, located in Chicago, Illinois, each resolution having been filed in this office on circh 25, 1982; and whereas a certified copy of a March 19, 1982 resolution of the Board of Directors of Reliance Federal Savings and Loan Association, located in Streamwood, Illinois was filed in this office of April 22, 1982; and

WHEREAS, each of the above reschitions certify that an identical Plan of Merger was adopted by each of the associations, a copy of which is attached hereto and made a part hereof; and

WHEREAS, the said Plan of Margar meats the requirements of Section 6-4 of the Illinois Savings and Loan Act:

NOW, THEREFORE, I, WARREN W. WILSON, Acting commissioner of Savings and Loan Associations of the State of Illinois, pursuant to Sections 6-5(c) and 6-7(a) of the Illinois Savings and Loan Act, do heraby approve the Plan of Herger and certify that Reliance Federal Savings and Loan Association, Streamwood, Illinois, a Corporation chartered under the law; of the United States of America, having obtained any necessary approvate from that chartering authority, shall along with Grunwald Savings and Lean Association, Chicago, Illinois, and United Savings and Loan Association, Chicago, Illinois, both being corporations chartered under the provisions of the Illinois Savings and Loan Act, marge with and into Guardian Savings and Loan Association, Chicago, Illinois, a Corporation chartered under the provisions of the Illinois Savings and Loan Act, and that Guardian Savings and Loan Association, the continuing association, whose name shall become UNITED SAVINGS ASSOCIATION OF AMERICA, effective with the recording of this Certificate of Merger, shall be considered the same business and corporate entity, with all the property rights, powers, duties and obligations as existed with regard to each of the aforementioned merging associations, in accordance with the said Plan of Merger; and I further certify that;

The name of the continuing association is UNITED SAVINGS ASSOCIATION OF AMERICA; and that

#### ARTICLE ONE

The name of the association is UNITED SAVINGS ASSOCIATION OF AMERICA

#### V" ICLE TWO

The initial location of the business office at the time of the adoption of these Articles of Incorporation is 3335 North Ashland Avenue, in the City of Chicago, County of Cook, State of Illinois

#### ARTICLE THREE

The Curation of the association shall be Perpetual

#### ARTICLE FOUR

The initial number of directors to be elected shall be thirteen

#### ARTICLE FIVE

The authorized cap tol represented by withdrawable shares which the association may issue shall be Unlimited

#### ARTICLE SIX

The date of the annual meeting of the members shall be First Friday of February

#### ARTICLE SEVEN

The quorum required for action of the members (except as otherwise provided by law) is 33 1/3% of the foral number of votes which all members of the association are entitled to cast


