RIDER TO STATE OF ILLINOIS MORTGAGE HUD-92116M (5-80)

This rider attached to and made part of the Mortgage between THOMAS E. HUGHES, DIVORCED NOT SINC MARY JO A. JURKOVIC. DIVORCED NOT , Mortgagor, and EVERGREEN HOME FUNDING CORPORATION SEPTEMBER 8, 1986 revises said Mortgage as follows:

1. Page 2, the second covenant of the Mortgagor is amended to read:

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums:

- (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged property (all as estimated by the nortgagee) less all sums already paid therefore divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rans, premiums, taxes and special assessments; and

 - (1) ground rents, if any, taxes, special assessments,
 - fire, and other hizard insurance premiums;
 (11) interest on the rate secured hereby, and
 - (111) amortization of principal of the said note.

Any deficiency in the amount of any such aggregate monthly payment shall, unless made good by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. The Mortgages may collect a "late charge" not to exceed four cents (4¢) for each dollar (\$1.00) for each payment more than fifteen (15) days in arrears, to cover the extra expense in olved in handling delinquent payments.

If the total of the payments made by the Mortgagor wider subsection (a) of the preceding paragraph shall exceed the amount of the payments actually made by the Mortgagee for ground rents, taxes and assessments, or insurance premiums, as the case may be, such excess if the losn is current, at the option of the Mortgegor, shall be credited on subsequent payments to be made by the Mortgagor, or refunded to the Mortgagor.
