- l. Within ten (10) days from the date of sale, the Sheriff shall file a duplicate of such Certificate of Sale in the Office of the Recorder of Deeds of Cook County, Illinois
- PROCEEDS AND REPORT OF SALE: Out of the proceeds of the sale, the Sheriff shall retain his fees and costs. Out of the remainder of such proceeds the Sheriff shall pay to the Plaintiff the amount by this Judgmana found to be due to the Plaintiff with interest on said sum, less the listed Plaintiff's attorneys' fees, at the rate of Nine (5t) percent per annum from the date of this Judgment to the date of sale. If the Plaintiff is the successful bidder, he shall not pay money to the Sheriff (other than for the Sheriff's costs and fees) but shall receive satisfaction of the Total Decree Indebtedness herein found due (with interest) to the extent lovered by the remainder of the Sale proceeds. 
