LAST WILL AND TESTAMENT

OF

PATRICK CARR

I, PATRICK CARR, of the Village of Forest Park, County of Cook and State of Illinois, do hereby make, publish and declare this to be my Last Will, and revoke all Wills and Codicils by me heretofore made.

FIRST: I direct my Executor hereinafter named to pay all of my just debts and funeral expenses as soon after my death as conveniently possible.

SECOND: I direct the payment of all estate, inheritance or other succession taxes and all duties and transfer charges and expenses which may be levied upon, or incurred in connection with, any gifts, transfers, bequests, legacies or devises made in this, my Will, or otherwise, shall be paid by my Executor out of the principal of my residuary estate. My Executor shall not seek reimbursement for any such payments. In her discretion my Executor may borrow money upon the credit of my estate and may pledge or mortgage all or any part of said estate as security therefor, for the purpose of paying such taxes, duties, transfer charges and expenses.

THIRD: I give, devise and bequeath all of my estate, real, personal or mixed, of every kind and nature and wheresoever situated, of which I may die seized or possessed, or over which

I may have power of appointment at the time of my death, or to which I may be entitled at the time of my death, to my wife, NOREEN CARR, if she survives me.

FOURTH: In the event my wife, NOREEN CARR, predeceases me, I give, devise and bequeath all of my estate, real, personal or mixed, of every kind and nature and wheresoever situated, of which I may die seized or possessed, or over which I may have power of appointment at the time of my death, or to which I may be entitled at the time of my death, to my children, THOMAS JOSEPH CARR, DANIEL TIMOTHY CARR, PATRICIA CLEMENT CARR, and KATHLEEN A. FOLEY, in equal shares, and if any child shall predecease me, then such share as such child might have taken shall go to his or her children, per stirpes and not per capita.

FIFTH: I nominate and appoint my wife, NOREEN CARR, as Executor of this my Last Will, and I request that she be not required to furnish surety for her bond as such Executor, or for the sale of real estate.

I authorize my Executor in her discretion, from time to time and without order of Court to sell all or any part of the estate, real or personal, which I may own or be entitled to at my death, at public or private sale, for cash or partly cash and partly credit, and upon such terms as to her may seem advisable. Such power of sale shall be general and shall not be restricted to purposes related to the administration of my estate.

My Executor may retain any of the estate which I may own or to which I may be entitled at the time of my decease and

may make distribution thereof in kind.

SIXTH: In the event my wife, NOREEN CARR, and I shall die in such manner that it is impossible to determine the survivor of us, then this, my Last Will and Testament, shall be construed as if she had survived me.


