Meyer, a Senior Vice President of the Corporation, in executing and delivering on October 24, 1986, in the name and on behalf of the Corporation, a certain Frichase Agreement, described at this meeting, pursuent to which the Corporation has agreed to sell to Harcourt Brace Jovanovich, Inc., for a cash purchase price of \$500,000,000 (subject to possible roat-closing adjustment) (i) substantially all of the business and assets (subject to specified liabilities) of the CBS Educational and Professional Publishing Division of the Corporation and (ii) the shares representing the Corporation's direct and indirect equity ownership in certain majority-owned subsidiaries engaged in the operations of said Division, on the terms and subject to the conditions provided for in said Purchase Agreement, be, and such action hereby is, ratified and confirmed.

RESOLVED that the officers of the Corporation be, and each of them hereby severally is, authorized, in the name and on behalf of the Corporation, to execute and deliver such collateral agreements and such instructions, powers of attorney, applications, deeds, filings with governmental authorities, and any other instruments related to or provided for in said Purchase Agreement, and to take all such other actions, as may be necessary or appropriate (such necessity or appropriateness to be conclusively evidenced by the execution thereof) to the consummation of the transactions provided for in said Purchase Agreement; and

RESOLVED that the CBS Pension Plan be, and it hereby is, amended, effective as of the Closing Date provided for in the Purchase Agreement described in the preceding resolutions, by adding the following as a new Section 4.12 to Article IV of said Plan:

"4.12. Any contrary provisions of this Plan notwithstanding, the retirement benefit of each participant in the Plan who is employed in one of the subsidiaries of CBS or units of the Educational and Professional Publishing Division of CBS that are the subject of a Purchase Agreement dated as of October 24, 1986, and who continues in the employ of the Purchaser under such Agreement after the Closing Date (as defined in said Agreement), determined under the provisions of this Plan, shall take into account any increases in the compansation of such participant while in the employ of the Purchaser prior to the first anniversary of the Closing Date."

I hereby further certify that Simon Volinsky is Vice President, Facilities Engineering and Real Estate, of the Facilities Department of CBS Inc., and is duly authorized and empowered to execute and deliver a deed and related instruments from the Corporation to Harcourt Brace Jovanovich, Inc., or its subsidiaries Pedagogical Press, Inc. and Universal Publications Corp., covering premises located at 2121 Touhy Avenue, Elk Grove Village, Illinois (as are more particularly described in Exhibit A annexed hereto) pursuant to the terms of the Purchase Agreement.
