3a. That Elsie Bee sold and assigned Certificate of Purchase of Forfeited Property Number F39610 to Leslie C. Barnard.

4. That the real estate hereinafter described has not been redeemed from the sale of March 13, 1984, pursuant to the judgment for sale as provided by Chapter 120 of the Revenue Act, and that the time for such redemption has expired on March 13, 1986.
