State of Illinois, County of Cook, City of Chicago, EDWARD A. QUINN, ENGINEER (No. 110), do hereby certify that a land survey has been made under our direction of the following described property:

That part of the West 1/2 of Section 3 Township 36 North, Range 12 East of the Third Principal Meridian bounded and described as follows:

Beginning at a point on the East line of the West 1/2 of said Section 3, 390.20 feet South of the Northeast corner of said West 1/2, measured along said East line, said point being also the point of intersection of the East line of said West 1/2 with the Easterly line of the right-of-way of the Wabash Railroad Company; thence South along the West 1/2 of said Section 3, 334.89 feet for a point of beginning thence continuing South along said East line of the West 1/2 of said Section 1916.71 feet more or less, to the Southeast corner of the Northeast 1/4 of said Section 3; thence West along the South line of the Northeast 1/4 of said Section 76.29 feet to a point; thence Northwest corner West 1/4 of said Section 3; thence West along the South line of the Northeast 1/4 at a point 275.66 feet South of the Northeast corner thereof; a straight line (which is extended) intersects the West line of said Northwest 1/4 at a point 150-foot right-of-way of the Wabash Railroad Company; thence Northwest along the arc of a circle having a radius of 5804.65 feet, convex to the Southeast, 112.11 feet to a point of tangency; said described arc being on the Easterly line of the right-of-way of the Wabash Railroad Company; a line drawn at right angles to said straight line tangent to said last described point, 1184.84 feet more or less, to the intersection with a line to the point of beginning (excepting therefrom a triangular shaped parcel for land described as follows: Beginning at a point on a line which extends West, perpendicular to the East line of said West 1/2 of Section 3, from a point thereon which is 334.89 feet South from the point of intersection of said East line with the Southeast 1/2 of Section 3; said point of beginning being 129.30 feet West from said East line of the West 1/2, and running thence Southwesterly a distance of 19.39 feet to a point which is 141.53 feet West from said East line of the West 1/2, and running thence above described perpendicular line; thence Northwest 115.10 feet to a point; thence South along said East line of the West 1/2, a distance of 30.76 feet to the point of beginning.)

The above described property is subdivided into lots, streets and drainage areas, all of which are shown in correct detail on the plat hereon drawn, distances are shown in feet and decimal parts thereof; angular bearings are shown in degrees, minutes and seconds.
