Go all to whom these Presents Shall Come, Greeting:

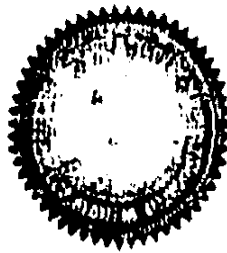
WHEREAS, OAK PARK NATIONAL BANK, located at ELEVEN WEST MADISON STREET, in OAK PARK, County of COOK, State of Illinois, has filed with my office, the necessary documents as prescribed under the provisions of "An Act of the General Assembly of the State of Illinois, known as the Illinois Banking Act," approved May 11, 1955, in force January 1, 1957, and acts amendatory thereto;

AND WHEREAS, it appears that said bank has followed the procedures prescribed by the laws of the United States to convert into a state bank;

AND WHEREAS, it appears from the evidence furnished the Commissioner as required by law that the capital stock of said bank, amounting to ONE MILLION TWO HUNDRED THOUSAND DOLLARS consisting of TWENTY-FOUR THOUSAND SHARES, of a par value of FIFTY DOLLARS each; the surplus amounting to ONE MILLION THREE HUNDRED THOUSAND DOLLARS, and the operating reserves of said bank exceeds the statutory minimum requirements prescribed in Sections 7 and 26 of the Illinois Banking Act;

NOW, THEREFORE, I, H. ROBERT BARTELL, JR., Commissioner of Banks and Trust Companies of the State of Illinois, by virtue of the power vested in me by the act aforesaid, do hereby approve the conversion of said bank to FIRST BANK OF OAK PARK, located at ELEVEN WEST MADISON STREET, in OAK PARK, County of COOK, State of Illinois, and authorize said bank to commence business as a bank under the provisions of the Illinois Banking Act for a term of PERPETUAL years, unless sooner terminated by the process of law.
