THAT PART LYING WEST OF A LINE (DESCRIBED AS BEGINNING AT THE SOUTH EAST CORNER OF LOT 7 IN MORS FARM SYNDICATE SUBDIVISION, UNIT NUMBER 1, A SUBDIVISION OF PART OF THE NORTH WEST 1/4 OF SECTION 12, TOWNSHIP 42 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, AND RUNNING SOUTHERLY IN A STRAIGHT LINE TO A POINT IN THE SOUTH LINE OF LOT 4, WHICH IS 372.0 FEET EAST OF ITS INTERSECTION WITH THE CENTER LINE OF MILWAUKEE AVENUE, BEING THE CENTER LINE OF PAVEMENT IN JOHN FORKE'S SUBDIVISION OF PART OF LOT 2 IN JOHN FORKE'S FARM BEING PART OF SAID SECTION 12) OF THAT PART OF THE NORTH WEST 1/4 OF SECTION 12, TOWNSHIP 42 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS:
