7. That the parties have entered into an Oral Separation Agreement which agreement the parties have found to be fair and equitable. The agreement has been presented to the Court and is set forth hereinafter as the Judgment of this Court.

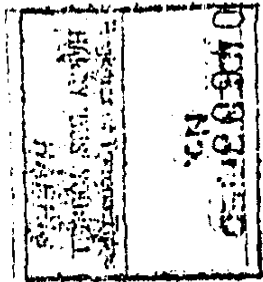
