- 1. The subject parcer of real estate (hereinafter referred to as "Property") is commonly known as 435-45 North Michigan Avenue, Chicago, Illinois, is legally described on Exhibit "A" attached hereto.
- 2. On or about April 24, 1985, NATIONAL WRECKING COMPANY (hereinafter referred to as "Sub-Contractor") entered into a contract with Schal Associates (hereinafter referred to as "Contractor"), said contract being thereafter reduced to writing, whereby Sub-Contractor was engaged to perform demolition and asbestos removal work on the Property. Sub-Contractor and Claimant, NATIONAL WRECKING COMPANY, has demolished and removed the said debris and asbestos to the extent required by the contract to date, and has done so to the agreed value of ONE MILLION TWO HUNDRED FIFTY THOUSAND SIX HUNDRED SEVENTY-SEVEN AND 26/100THS DOLLARS (\$1,250,677.26), all of which

said services were furnished upon the Property and structures located thereon, thereby constituting a valuable improvement of the Property. The last of said services were so provided by the Sub-Contractor and Claimant, NATIONAL WRECKING COMPANY, on December 23, 1986.

- 3. After allowing for any and all just credits, there remains due and owing for the services so provided and furnished by Sub-Contractor and Claimant, the sum of SEVENTY-ONE THOUSAND THREE HUNDRED AND 26/100THS DOLLARS (\$71,300.26).
- 4. Sub-Contractor and Claimant, NATIONAL WRECKING COMPANY, now claims a lien upon the Property, and all improvements thereto, any and all monies due from the Owner to the Contractor and against all persons interested therein for the amount of \$71,300.26, together with interest as provided by statute.
