SUBORDINATION OF MORTGAGE

THIS SUBORDINATION AGREEMENT is made this 7 day of April, 1987, by Continental Illinois National Bank and Trust Company of Chicago ("CINB").

("Refinancing Lender") dated 04/27/87 and recorded on as Document No. 206237 to secure repayment of a Note for One Hundred Twenty Five Thousand Dollars (\$ 125,000.00) with interest payable as provided in the Note; and
