MORTGAGE

TOGETHER with all the improvements now or hereafter erected on the casements, rights, appurtenances, rents, royalties, property, and all mineral, oil and gas rights and profits, water rights, and water stock, and all

fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together, with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

BORROWER covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower, will warrant and defend generally the title to the Property against all claims and demands, subject to any exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

UNIFORM COVENANTS. Borrower, and Lender covenant and agree as follows:

- Paymer,c and Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Agreement as provided in the Agreement, including any Future Advances secured by this Mortgage.
- Payment of Taxes, Insurance and Other Charges. Borrower shall pay all 2, taxes, hazard insurance promiums, assessments, and othe charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, If any, and all payments due under any Mortgage or Trust Dood disclosed by the title insurance policy insuring Landar's interest in the property, if any. Borrower shall promptly furnish to Londor all notices of amounts due under this paragraph and Borrower shall promptly furnish to Londor receipts evidencing such payments. Borrower shall promptly discharges any lien which has priority over this Mortgage; provided, that Borrower shall not be require to discharge any such lien so long as Borrowor: (a) shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Landor, (b) shall in good faith contest such lien by, or defend against enforcement of such lien in, legal proceedings which in the opinion of Lander operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof; or (c) shall secure from the holder of such lien an agreement in a form satisfactory to Lender subordinating such lion to this Mortgage.

If Londor determines that all or any part of the Property is subject to a lien which may attain a priority over this Security Instrument, Lender shall send Borrower notice identifying such lien. Borrower shall sociaty such lien or take one or more of the actions set forth above within ten days of the giving of notice.

- 3. Application of Paymonts. Unless applicable law provides orbanise, all payments received by Londor first in payment of interest payable on the Agraement, then to any charges and then to the unpaid balance of the Agraement.
- Borrower shall keep the improvements now existing or 4. Hazard Insurance. hereafter erected on the Property insured against less by fire, hazards included within the term "extended coverage", and such other hazards as Lender may require and in such amounts and for such poriods as Lender may require; provided, that Londer shall not require that the amount of such coverage exceed that amount of coverage required to pay the sums secured by this Mortgage.

The Insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lender; provided, that such approval shall not be unreasonable withheld. All premiums on insurance policies shall be paid by Borrower making payment, when due, directly to the insurance carrier.

All insurance policies and renewals thereof shall be in form acceptable to Londor and shall include a standard mortgaged clause in favor of and in form acceptable to Lender, Londor shall have the right to hold the policies and renewals thereof, and Borrower shall promptly furnish to Lender Jall renewal notices and all receipts of paid premiums. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage should be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. If the Property is abandoned by Borrower, or if Borrower fails to respond to lender within 30 days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the syms secured by this Mortgage.

Unless Lander and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to paragraph 1 hereof or change the amount of such installments. It under paragraph 17 hereof the Property is acquired by Lender, all right, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to the sale or acquisition

- 5. Preservation and Maintenance of Property; Leaseholds; Condominiums; Planned Unit Developments. Sourower shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provision of any lease if this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominuum or a Planned Unit Development, Borrower shall perform all of Borrower's obligations under the declaration of covenants creating or governing the condominium or Planned Unit Development, and constituent documents. If a condominium or Planned Unit Development rider is executed by Borrower and recorded together with this Mortgage, the covenants and agreements of such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Mortgage as if the rider were a part hereof.
- 6. Protection of Lender's Security. If Borcower fails to perform the covenants and agreements contained in this Mortgage, or if any action or proceeding is commended which materially affects Lender's interest in the Property, including, but not limited to, eminent domain, insolvency, code enforcement, or arrangements or proceedings involving a bankrupt or decedent, then Lender at Lender's option, upon notice to Borrower may make such appearances, disburse such sums and take such action as is necessary to protect Lender's interest, including, but not limited to, disbursement of reasonable attorney's fees and entry upon the Property to make repairs.

7. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower notice prior to any such insepction specifying reasonable cause therefore related to Lender's interest in the Property.

8. Condomnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condomnation of other taking of the Property, or part thereof, or for conveyance in lieu of condomnation, are hereby assigned and shall be paid to Lender.

In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such propertion of the proceeds as is equal to that propertion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Borrower, or if, after notice by Lender to Borrower that the condemnor effers to make an award or settle a claim for damages, Borrower fails to respond to Lender within 30 days after the date such notice is mailed, Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or the sums secured by this Mortgage.

Unless Lenger and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to in paragraph 1 hereof or change the amount of such installments.

- 9. Borrower Not Released. Extension of the time for payment or modification of amortization of the sum secured by this Mortgage granted by Lender to any successor in interest of Borrower shall not operate to release, in any matter, the limbility of the original Borrower and Borrower's successors in interest. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest.
- 10. Forbearance by Lender Not a Wilver. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be waiver of or preclude the exercise of any such right to remedy. The procurement of insurance or the payment of taxes or other liens or charges by Lender shall not be a waiver of Lender's right to accelerate the maturity of the indebtedness secured by this Mortgage.
- 11. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this mortgage or afforded by law or equity, and may be exercised concurrently, independently or successively.
- 12. Successors and Assigns Bound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bind, and the rights hereunder shall insure to, the respective successors and assigns of Lender and Borrower, subject to the provision of paragraph 16 hereof. All cryenants and agreements of Borrower shall be joint and several. The captions and hearings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define and provisions hereof.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrower provided for in this Security Instrument shall be give by delivering it or by mailing it by first class mail addressed to Borrower at the property address, and (b) any notice to Lender shall be given by first class mail to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Security Instrument shall be deemed to have been given to Borrower or Lender when given in the matter designated herein.
- 14. Uniform Security Instrument; Governing Law; Serverability. This form of Security Instrument combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform

15. Borrowar's Copy. Borrower shall be furnished a conformed copy of the Agreement and of this Mortgage at the time of execution or after recordation

If all or any part of the Property or an interest therin is sold or transferred by Borrower (or if a baneficial interest in Borrower is sold or transferred and Borrower is not a natural person or persons but is a corporation, partnership, trust or other legal entity) without Lander's prior written consent, excluding (a) the creation of a lien or ancumbrance subordinate to this Security Instrument which does not relate to a transfer of rights of occupancy in the property, (b) the creation of a purchase money security interest for household appliances, (c) a transfer by devise, descent or by operation of law upon the death of a joint remant of (d) the grant of any leasehold interest of three years or less not containing an option to purchase, Lander may, at Lander's option, declare all the sums secured by this Security Instrument to be

immediately due and payable.

If Lander exercises such option to accelerate, Lender shall mail Borrower notice of acceleration in accordance with paragraph 13 hereof. 17. Acceleration; Remedies. Except as provided in paragraph 16 hereof, upon Borrower's breach of any covenant or agreement of Borrower in this Mortgage, including the covenants to pay when due any sums secured by this Mortgage, Lender prior to acceleration shall mail notice to Borrower as proved in paragraph 13 heref specifying; (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 30 days from the date the notice is mailed to Borrower, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property.
